Scope of Work & GUIDELINES FOR SUBMISSION OF TENDER

A 3D Theatre with capacity for about 150 audiences has been set-up in Sanjay Gandhi Biological Park, Patna. Tender is invited from the competent, experienced and reputed agencies/firms dealing in supply of 3D Hindi dubbed Films. Sanjay Gandhi Biological Park, Patna requires the following Hindi dubbed 3D Movies:

- 1. Nature-based documentaries or short 3D movies.
- 2. Jungle Book episodes
- 3. The Lion King etc.

Last date and time of submission of TENDER to SGBP	Up to 1.00 P.M. on or before 13.03.2024 at the office of the Director.
Opening of TECHNICAL BID of Tender	On 13.03.2024 at 3.00 P.M in the office of the Director.
Opening of Financial Bid	13.03.2024 at 03:00 PM in the office of Director.
Time of Completion of work.	30 (thirty) days from issue of work order.

- 2. The film files shall be Full HD (1920x1080) in mpeg (Left and Right separate) Audio tracks shall be compliant with 5.1 Dolby surround sound system. Interest agencies/firms are required to submit their Tender with details i.e. duration & price of each film on or before the time prescribed above in the office of the Director, Sanjay Gandhi Biological Park, Patna.
- 3. The tender should be submitted in two parts in two separate sealed envelopes / packets (Technical bid and Financial bid) and put together in one single sealed outer envelope / packet (Master Envelope) super scribed with "Tender for supply of 3D Movies". The two parts of the proposal are:-

"Technical Bid". (Part/Cover-1)

This includes the following documents for technical eligibility;

- 1. Track record details of involvement in similar supplies with supply order (copies should be enclosed as proof).
- 2. Statement signed by a statutory auditor, indicating turnover of the company of last three years. The turnover shall not be less than 20 lacs.
- 3. Photocopy of TIN and PAN duly attested by bidder.
- 4. Photocopy of Aadhar Card duly attested by bidder
- 5. Demand draft for rupees 2000/- (rupees two thousand only) towards application fee drawn in favour of "Director, Sanjay Gandhi Biological Park" payable at Patna. (Non-refundable)
- 6. D.D./ F.D.R. of Rupees 1,00,000/- (One lakh) only towards Earnest Money Deposit in favour of Director, Sanjay Gandhi Biological Park, payable at Patna (refundable after liability period).
- 7. Address proof, identity proof.
- 8. Declaration from Notary that he is not black-listed by any Govt./Semi Govt. agency.
- 9. Declaration from Notary that the documents submitted by him is true and if found false, he will be punished and black-listed.
- 10. Signature of bidder duly attested by Gazetted Officer.

All annexure as detailed in the document (excluding details/annexures comprising the financial bid) should be signed by the bidder which are to be enclosed in the technical bid. Tenders containing submission of the financial bid/details in the technical bid shall be rendered disqualified.

Part / Cover - 2: Super scribed with "Financial Bid".

The bidders will quote their price for the following 3D Movies separately and duration of each film, validity of film,

- 1. Nature-based documentaries or short 3D movies.
- 2. Jungle Book episodes
- 3. The Lion King etc.
- 4. The tender should be type-written. The application shall be signed by the person himself in case of an individual, by the proprietor in case of a proprietary firm; by the duly authorized person holding the power of attorney for signing the application accompanied by a copy of the power of attorney.
- 5. Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing, dating and rewriting. Pages of the eligibility criteria document are numbered. Additional sheets, if any added by the contractor, should also be numbered by him. They should be submitted as a package with signed letter of transmittal.
- 6. References, information and certificates from the respective clients certifying suitability, technical knowledge or capability of the applicant should be signed by Project Authority.
- 7. The Director reserves the right, without being liable for any damages or obligation to inform the applicant to reject any or all of the applications without assigning any reason.
- 8. After evaluation of technical bid, a list of short-listed bidders will be prepared. Thereafter, the price bid of only qualified and technically acceptable bidders shall be opened at the notified time, date and place in presence of qualified bidders or their representatives. If tenderer or their authorized persons is not present at the time of opening of technical bid/financial bid, the bid will remain valid.
- 9. The department shall not be liable to pay any interest on the money deposited by the applicants.
- 10. The tenderer shall be bound to complete the work within stipulated time. There shall not be any extension thereof
- 11. The applicants shall be bound to present the original documents of all the annexures on demand at the time of opening of the technical bid.
- 12. In case of holiday on relevant dates of the tender, the fixed date shall be replaced by the next working day. There shall not be separate information given in this regard.
- 13. The bidders shall have to submit their bids either physically in the tender deposition box or through registered post on/or before the due date. For bids being deposited through registered post, SGBP will not be responsible for any late receipt of the bid documents.
- 14. It is the duty of the supplier to ascertain that the film supplied by him is functions effectively and efficiently.

- 15. The Director, Sanjay Gandhi Biological Park, Patna reserves the right to cancel any or all bid without assigning any reason or to negotiate the prices with the successful bidder irrespective of the prices quoted in the financial bid.
- 16. Any legal dispute will be allowed in the jurisdiction of Patna only.
