Sanjay Gandhi Biological Park, Patna has a lake within the Park campus. The lake has a surface area of about {8 acres approx.}. Water depth varies from (Minimum, 5'-0" ft. to Maximum 7'-0" ft.). The overall volume of the water is {Cubic Feet 9,50,000 approx.}. The lake is also used by visitors for boating and other ecotourism services. There is a proposal to improve the water quality of this lake.

Separate/Online Bids are invited from registered Indian Suppliers {Manufacturers (OEMs) / Authorized Distributors / Dealers / Suppliers} for supply of Air Diffusion System (ADS) Fine Bubble Aeration system.

Specification of the ADS system to be installed are as follows: -

### FINE BUBBLE AERATION TUBING SPECIFICATION:

- 304 Stainless Steel Disk Modules each with 100' weighted Aeration Triple Cut Aeration Tubing "LTC"
- Optimum Air Supply 8.1 SCFM (Standard cubic feet per minute)
- Fluid Turnover Rate @ 15ft. Water Depth >20 MGD (Million Gallon per day)
- 3/4" "ADS" weighted Feeder Tubing

### **COMPRESSOR / BLOWER TECHNICAL SPECIFICATION:**

- 1. Compressor / Blower to deliver minimum 64 SCFM of filtered air at 6 PSI.
- 2. Oil Less Air Quiet Compressor / Blower
- 3. Max. rated motor power 22 kw

### **SPECIFICATION FOR THE AERATION:**

- a) Oxygen Transfer: "ASCE" Certified minimum of 50% efficiency in 5 meters of clean water.
- b) Bubble Performance:

- i) Maximum bubble diameter 0.125" (3mm)
- ii) Average rise rate of bubble for laminar flow 0.8 feet per second (0.24m per sec.) not to exceed one feet per second.
- iii) The fluid turnover rate (at 5-meter water depth) shall meet or exceed 3000 Cum. Per Hour.

### **IMPROVEMENT IN THE WATER QUALITY:**

Reduction in BOD to 3 mg/l (5 days at 20° C) on continuous running of system in 365 days without resorting to any chemical treatment.

The quoted price should include cost of equipment, testing, commissioning, 5 years warranty on all the water aeration components. The quoted price should include one year warranty on all other equipment and cost of AMC for three years including the material cost.

#### **GENERAL TERMS AND CONDITIONS**

#### FOR

# Establishment of ADS fine Bubble Aeration System in Lake of Sanjay Gandhi Biological Park, Patna.

- 1. The Tenderer are expected to read carefully all the terms and conditions of the tender documents and their submission will be taken as consent to abide. Tenderers are advised to visit the site, examined and understood the scope of work.
- 2. If the Tenderer gives deliberately wrong information to create conditions for acceptance of the tender, Director, Sanjay Gandhi Biological Park, Patna, reserves the right to reject such tenders without assigning any reason. Not more than one tender will be submitted by one bidder for the same work. Legal action will be taken for furnishing wrong information.
- 3. Track record details of involvement in similar works information together with work order copies regarding order receipt/completeness of such furnished information. The Agency/Company/Individual shall have an experience of at least five years in the field of similar work.
- 4. Specific experience relating to the particular work. Agency/ Company/ Individual should have executed at least one similar projects in India of amount each not less than Rupees 35 lacs. Attach supportive documents.
- 5. The tenderer will make a presentation for execution of the project as required by Tender Committee on the date fixed for this purpose.
- 6. Evaluation of bid by Technical Committee:

The Technical Evaluation Committee may call the responsive bidders for discussion or presentation to facilitate and assess their understanding of the scope of work and its execution. However, the committee shall have sole discretion to call for discussion/presentation. So, all bidders should be ready with a brief presentation. The Technical Evaluation Committee shall have right to accept or reject any or all tenders without assigning any reasons thereof.

7. **Manner of Submission of Tender**: The tender should be done on two bid method viz 1) Technical Bid & 2) Financial / Price Bid. The bidders should ensure that the Technical bid complete in all respect and containing the required enclosures.

### "Technical Bid" shall contain:-[as per Annexure -1]

- 2. Proof of EMD deposit of Rupees 2,00,000/- (two lakh) only
- 3. Photocopy of PAN No./TAN No. and Income Tax return of last three years (2018-19; 2019-20 & 2020-21).
- 4. Photocopy of GST registration.
- 5. Proof of involvement in similar works information together with work order copies regarding order receipt/completeness of such furnished information. The Agency/ Company/Individual shall have an experience of at least five years in the field of similar field.
- 6. Proof of turnover duly signed by a statutory auditor (shall not be less than 01 crore.)
- 7. Photocopy of Address proof & Identity proof.
- 8. Specimen signature attested by Gazetted Officer.
- 9. Declaration regarding black-list.
- 10. An affidavit duly certified by (enclosed/ Not enclosed) the notary at the location of the Agencies/Headquarters Patna that the bidder has never been black listed or punished by any court for any criminal offence/breach of contract and that no police/vigilance enquiry/criminal case is pending against either bidder legal entity or against individual Directors of the company or partners etc. of the firm etc..

Note: All documents duly self-attested should be uploaded in E-tender. Original documents to be shown by the bidder to the Committee at the time of opening of financial bid.

### 8. "FINANCIAL BID": - The financial bid shall contain:

Financial/Price Bid Form [as per Annexure – 2] The tenderer shall give the total composite price inclusive of all levies and taxes (inclusive of taxes) and the person (s) for operating the machine 24x7 during contract period i.e. 3 years. The prices quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account. This quoted price will include Design, Fabrication, Supply, Testing, Installation and Commissioning/Establishment, maintenance and operation of ADS Fine Bubble Aeration system for 3 years in the lake of Sanjay Gandhi Biological Park, Patna. The date of Comprehensive maintenance will start once the system is commissioned on the site. The decision will be taken on the total cost of the system including comprehensive maintenance for three years.

### 9. Forfeiture of Earnest Money:-

- a. If the Tenderer withdraw their Bids after opening of the same or the successful bidders withdraw their Bid after approval of their rates.
- b. If the successful bidders fails to supply or refused either partial or total offer (Acceptance) made by The Director, Sanjay Gandhi Biological Park, Patna.

### 10. Return of Earnest Money:-

- a. After finalization of the Tender, the deposited Earnest Money will be returned back to the unsuccessful bidders.
- 11. **Deposition of Security Money:-** The selected tenderer must deposit the requisite amount of Security Money i.e., 10% of the tender amount within the stipulated date specified in the acceptance letter in

the form of Demand Draft Payable at Patna duly pledged in favour of Director, Sanjay Gandhi Biological Park, Patna.

### 12. Forfeiture of Security Money:-

- a. In the event of failure to supply or maintain the goods/articles/equipment / instruments as per Work Order within the stipulated period, the security deposit may be forfeited
- b. If any equipment/ instrument is damaged by the firm, cost of the same will be deducted from the deposited Security money of the contractor.
- c. In the event of any kind of dis-satisfaction, then the same (security money) will be forfeited without any reason given to the party.
- 13. **Refund of Security Deposit** After successful completion of project and defect liability period, Security Deposit will be refunded within three months if not extended for further maintenance.

### 14. AWARD OF CONTRACT: PLACEMENT OF ORDER

The Tender Committee shall consider placement of orders for jobs on those bidders whose offers have been found technically, commercially and financially acceptable. The Director, Sanjay Gandhi Biological Park, Patna reserves the right to counter offer price(s) against price(s) quoted by any bidder. Acceptance of lowest tender is not obligatory.

#### 15. DEFECT LIABILITY PERIOD

The contractor shall replace all good at his own cost and to the satisfaction of the employer all defects, shrinkage, settlements or other faults which may appear within the period of contract, defect liability period and A.M.C. period and no extra payment will be made for replacement of any article(s). Defect should be rectified immediately by the successful tenderer.

- 20. Regarding Supply and Charges for repairing, Abnormal Low Rate or Abnormal High Rates (in comparison to the market Rate) will not be considered even his being the lowest rate.

#### 21. ARBITRATION

If any dispute arises between parties to the Contract it shall be under the jurisdiction of Civil Court at Patna.
