# Terms and Conditions for Supply of Diagnostic, Health Monitoring and Treatment required in the Wildlife/Veterinary Hospital of Sanjay Gandhi Biological Park, Patna

- Separate technical and Financial Bids from Registered Indian Suppliers {Manufacturers (OEMs)/ Authorized Distributors/ Dealers/ Suppliers} for the supply of Diagnostic, Health Monitoring and Treatment as per the specified item wise requirements and technical specifications can be submitted in the office of Director, Sanjay Gandhi Biological Park, Patna, upto 01.03.2025 till 3:00 PM.
- 2. The main purpose of this tender is to procure the machinery required for Zoo Hospital at Sanjay Gandhi Biological Park, Patna. Sanjay Gandhi Biological Park has 93 different species of animals and birds of Felids like Big Cats (Lion, Tiger, Leopard etc), Small Cats (Jungle Cat, Fishing Cat, Leopard Cat), Canidae (Indian Wolf, Striped Hyena, Jackal, Wild Dog, Indian Fox), Ursidae (Sloth Bear, Himalayan Bear) Primates like Gibbon, Chimpanzee, Herbivores like Rhinoceros, Hippopotamus, Elephant, Giraffe, Zebra, Nilgai, Sambhar, Chital, Blackbuck, Hog deer, Barking deer; Reptiles like Turtles, Snakes; Birds like Emu, Ostrich, Macaw, Vulture etc. This hospital is not a regular veterinary hospital for domestic animals, but it is a zoo hospital where wild animals will be treated when required. The portable machinery and equipment instead of fixed one will be preferred. Also, bidders must provide only such machinery and equipment which will be used for all the wildlife mentioned above. The machinery found non-useful to above mentioned species of wildlife will be returned back without making any payment towards it. No compensation will be entertained for return of such non-useful machinery.
- 3. Tender Documents along with detailed descriptions of the item and Terms and Conditions of the Tender can be purchased from office of Director, Sanjay Gandhi Biological Park, Patna on payment of cost of Tender Document/Tender Fee of Rs. 5000/- (Five Thousand Rupees only) as well as it can be downloaded from <a href="https://state.bihar.gov.in/forest">https://state.bihar.gov.in/forest</a>. In case the bidder downloads the tender documents from website, the cost of tender document/Tender fees will be submitted by the bidder along with the technical bid in the form of a Demand Draft of Rs. 5,000/- (Five Thousand Rupees only) drawn in favour of Director, Sanjay Gandhi Biological Park, Patna payable at any scheduled bank at Patna. The bid without DD or money receipt for tender fees will be declared technically disqualified and will not be considered. The DD should be submitted in original. Submission of Photocopy of DD as tender fees will not be accepted and the bid will be declared technically disqualified and will not be considered.
- 4. The cost of tender document/Tender Fee is non-refundable.
- 5. The technical bid and the financial bid should be sealed by the bidder in separate envelopes duly superscribed and both these sealed envelopes are to be put in a bigger envelope which should also be sealed and duly superscribed. The bidder must mention Tender details, Name and address of bidder on the envelope.



- 6. The technical bid will be opened in the office of Director, Sanjay Gandhi Biological Park, Patna on 01.03.2025 at 4.00 PM before Tender committee in the presence of bidders or Authorised representatives of bidders. In case any bidder/authorised representative of the bidder remain absent at the time of opening of technical/financial bid, the bid will be considered valid for evaluation.
- 7. Bids along with necessary documents must be submitted in the office of Director, Sanjay Gandhi Biological Park, Patna before the date and time specified in the NIT. The department/Tendering Authority doesn't take any responsibility for the delay / Non Submission of Tender for any reason. Late bids (i.e. bids received after the specified date and time for receipt of bids in NIT) will not be accepted and considered.
- 8. The technical bids will be opened by the Tender committee at the first instance for evaluation. Financial bids of only the technically acceptable offers will be opened for further evaluation and ranking.
- 9. Tender will be valid for the financial year 2024-25.

#### **Technical Bid**

- 10. The bidders shall submit their eligibility and qualification details, Certificates in support of their eligibility criteria / technical bids and other certificate /documents as mentioned in tender documents, only in the formats given in the tender document.
- 11. The bidder shall sign on all the pages of tender documents, supporting statements, documents, certificates submitted by him, owning responsibility correctness/authenticity. The self- attested copy of terms and conditions along with NIT need to be attached along with technical bid else the bid will be declared disqualified.
- 12. The bidder must attach original money receipt/Demand Draft of Rs. 5000/- in technical bids as proof of tender fees.
- 13. Earnest Money Deposit (EMD) of Rs. 50,000/- (Rupees Fifty Thousand Only) will be in the form of a Demand Draft drawn from a Scheduled Bank in favor of Director, Sanjay Gandhi Biological Park, Patna and payable at any scheduled bank in Patna. The Demand Draft of Earnest Money Deposit need to be attached along with the Technical Bid. In the absence of EMD, the technical bid will be declared disqualified.
- 14. The bidder must attach a self-attested photocopy of address and identity proof.
- 15. The bidder must attach a copy of partnership deed in case of firm along with letter of authorization to represent the firm.
- 16. The bidder must be registered to Income Tax Department. A self-attested copy of the PAN Card and copy of IT return filed for the last two assessment years (Assessment Year 2023-24 and 2024-25) has to be attached with the technical bid.
- 17. The bidder must be GST registered. A self-attested copy of the GST Registration and copy of GST quarterly return filed for the last two quarters has to be attached with the technical bid.
- 18. The bidder must have annual turn-over above Rs. 25,00,000/- (Twenty Five Lakh Rupees only) for last two years. The bidder must enclose along with technical bid, the documents issued by certified chartered accountant, showing annual turnover of last two years (2022-23 and 2023-
- 19. The bidder must submit the photocopy of Character Certificate issued by the authorized Officer, Address proof & Identity proof duly self-attested by the Tenderer.
- 20. The bidder must attach documents/certificates regarding the experience of supply of veterinary machineries/equipment of aggregate value of minimum 5 Lakhs, to any Zoo in India, Veterinary Hospital, Veterinary College, any other Government veterinary office/Institute or Forest Department office within last 3 years. In the absence of documents regarding experience of specified cost, the bid will be declared technically disqualified. If the bidder is Authorized Distributors/ Dealers/ Suppliers, then the experience certificate of OEM as experience certificate of bidder will not be considered. The experience certificate should be in the name of participating bidder. P.T.O.

- 21. The bidder must enclose with the technical bid the Booklet or brochures containing photographs and technical specifications of the machinery/equipment along with the specifications of the machinery/equipment that will be supplied by the bidder. In the absence of the Booklet or brochure, the bid will be declared technically disqualified. Bids of only those machineries will be considered for which Booklet or brochure and technical specification is submitted in technical bid. Only such machineries/equipment's satisfying the specifications provided will be evaluated in the financial bids. i.e. if only 6 out of 10 machineries provided by a bidder qualifies the technical specifications, financial bids for only those machineries will be considered.
- 22. During technical bid evaluation, the bidder must give offline/online demo of the machineries/equipment to be supplied in front of tender committee. Financial bids of only such tenderers will be considered who gives satisfactory demonstration of the machineries/equipment being supplied in front of tender committee. The link for online demo will be provided on the day of opening of technical bids.
- 23. The bidder must submit self-attested photocopy of the authorization certificate issued by the manufacturer of the machineries/equipment's, for which technical bid is submitted by the bidder. In the absence of such authorization certificate/letter, the bid for that equipment/machinery will not be considered. Only such machineries/equipment's for which authorization certificate is provided will be evaluated in the financial bids.
- 24. The bidder must submit Notarized affidavit regarding declaration of not included in the black-list by Govt or any other agency.
- 25. The bidder must submit Notarized affidavit regarding certifying that they have read and agree with all the terms and conditions of the tender and he/she accepts the terms and conditions of the tender.
- 26. The bidder must submit Notarized affidavit regarding submission of true documents.
- 27. It will be the responsibility of the bidder to provide Registrations/ Permissions/ Authorizations/ NOC etc. issued by the concerned Government Department/institution/Board or any other body authorized for such purpose for the operation and installation of the equipment/machinery to be supplied.
- 28. Any issue regarding any machinery will be resolved by the committee. Committee may alter/correct the specification of the machinery, if it is felt necessary to do so. The decision of the committee regarding the finalization of specification of machinery will be final and binding on the bidders.
- 29. In no case successful bidder can change or request to change, the machinery or the specification which has been submitted in the technical bid for unavailability or any other reason.
- 30. The bidder must specify the Annual Maintenance schedule for the machinery to be supplied.
- 31. Committee will have all the right to disqualify the bid if any malpractice or tempering is found in the submitted bid document.
- 32. The bidder must supply the machinery/equipment's within 15 days of issuing of the purchase order by Director, Sanjay Gandhi Biological Park, Patna. If the supply of machinery requires more than 15 days due to any acceptable reason, the reason and the time required for the delivery must be mentioned along with the technical bid. The committee can reject the bid technically, if it is found that undue time for supply is quoted by the bidder.

#### **Financial Bid**

- 33. The bidder must mention the cost of machinery/equipment's in digits and well as in words clearly without any overwriting.
- 34. The cost of machinery/equipment submitted by the bidder will be inclusive of all taxes, GST, cess, fees, fees required for registration/Authorization/NOC etc. of the equipment, transportation cost till Sanjay Gandhi Biological Park, loading, unloading and installation etc. of the machinery/equipment's. No extra/hidden charges will be payable from Sanjay Gandhi Biological Park, Patna side apart from the cost submitted by the bidder in the financial bids.

- 35. The cost of machinery/equipment will include AMC charges applicable during warranty period of three years (3 yr) of the machinery/equipment. No separate charges will be paid for annual routine maintenance of the machinery during warranty period of the machinery/equipment.
- 36. The cost of material submitted by the bidder must include any other charges or changes in the tax rates etc. as communicated by the central or state government from time to time.
- 37. Evaluation of the financial bid will be based on the minimum of submitted cost for each machinery/equipment by technically approved bidders.

#### Supply, Delivery and Maintenance of Machinery/Equipment

- 38. The purchase order for the procurement of the machinery/equipment will be issued after getting approval for the technical and financial evaluation from competent authority.
- 39. The delivery of the machinery/equipment must be done only to the authorized officer as communicated by the Director, Sanjay Gandhi Biological Park, Patna.
- 40. Successful bidder must supply the machinery/equipment's within 15 days of issuing of the purchase order by Director, Sanjay Gandhi Biological Park, Patna.
- 41. At the time of delivery of the machinery/equipment's, the successful bidder will arrange for the demonstration of the machinery/equipment in front of the technical committee constituted by Director, Sanjay Gandhi Biological Park, Patna.
- 42. The payment of the machinery/equipment's supplied will be done by the authorized officer only after delivery of the machinery and approval of the technical committee after demonstration of the machinery/equipment by the bidder after installation.
- 43. The successful bidder must repair of the machinery for any technical malfunctioning and must provide the resources for the Maintenance of the machinery as per schedule, within 7 days of communication from the office of Director, Sanjay Gandhi Biological Park. In case the successful bidder fails to provide repairing services within stipulated time, the Director, Sanjay Gandhi Biological Park, Patna will have all the rights to blacklist the bidder and to forfeit the security money deposited by the bidder.
- 44. Bidders must abide to all the necessary directions/guidelines communicated by the Centre/State government from time to time regarding supply and payment of the machinery/equipment's.
- 45. The Director, Sanjay Gandhi Biological Park, Patna will have all the rights to cancel purchase of any or all of the machinery/equipment's without communicating any reason to the successful bidder.
- 46. The successful bidder will submit a non-judicial stamp paper of Rs. 1000/- (One Thousand Rupees only) for the agreement within a week of issuing of order in this regard.
- 47. The successful bidder will have to deposit security money equal to 10% of the total cost of the machinery/equipment in the form of Fixed Deposit/Bank Guarantee of any nationalized bank pledged in the name of Director, Sanjay Gandhi Biological Park, with maturity period of minimum 3 years or maximum warranty period of the all the machineries/equipment's to be supplied, whichever is maximum. The security deposit will be returned back to the successful bidder after 3 years or expiry of warranty period of all the machineries that are supplied by the successful bidder, whichever is later.
- 48. The Director, Sanjay Gandhi Biological Park will have all the rights to forfeit security deposit in case malfunctioning of Machinery/equipment during warranty period of three years or if successful bidder fails to provide necessary services/regents as and when asked, for annual maintenance or repairing/replacing of the machinery/equipment's.
- 49. The EMD of unsuccessful bidder will be returned within 2 weeks of the date of finalization of
- 50. If it is brought to the notice of the committee that the machinery of same specification is available in the market at the cost less than that submitted by the successful bidder, the bidder must provide the machinery at this lower market rate.

- 51. If L1 bidder fails to supply the material within stipulated time or do not abide any of the terms and conditions of the tender, the supply of the machinery can be ordered from other bidders at L1 rate.
- 52. If the successful bidder do not conform to the terms and conditions of the tender or do not supply the machinery/equipment's within stipulated time, Director, Sanjay Gandhi Biological Park, Patna will have all the right to cancel the contract and forfeit the security deposit as well as to blacklist the bidder from participating in any tender or supply of materials to any government agency.
- 53. If the successful bidder supply any machinery/equipment of lower quality, then it will be the responsibility of the bidder to remove the machinery/equipment's from the site of delivery/installation with his own expenses within a week of communicating the same. If the bidder fails to remove such machinery/equipment of lower quality from the site, Director, Sanjay Gandhi Biological Park, Patna or any officer authorized by him. The cost of removal of machinery/equipment from the site of delivery/installation will be recovered from the bidder from his security deposit/EMD. The department will not be responsible for any damages to the machinery/equipment during this process.
- 54. Any dispute regarding quality or quantity of the supplied machinery/equipment's will be decided by the technical committee appointed by Director, Sanjay Gandhi Biological Park, Patna. If bidder is not satisfied with the decision of the committee, then the final decision will be taken by the Director, Sanjay Gandhi Biological Park, Patna which will be binding on the bidder.
- 55. Supply of the machinery/equipment will be done by the successful bidder only.
- 56. The bidder must submit the notarized affidavit certifying that they have read and agree with all the terms and conditions of the tender and he/she accepts the terms and conditions of the tender.
- 57. The Director, Sanjay Gandhi Biological Park, Patna will have all the rights to cancel part or complete tender without mentioning any reasons for the same.

58. The legal jurisdiction of any dispute arising regarding this tender will lay within the jurisdiction of competent court in Patna.
