(2) Scope of Work

- 1. Existing signages in the Zoo are too varied in their design and content and there need to be uniformity in the design types for the Zoo.
- 2. Many areas need new signages and different themes and concepts for these signages need to be worked out.
- 3. Success stories of captive breeding and birth of animals in the Zoo will also be highlighted through signages in the Zoo.
- 4. Pathway for moving around different animal enclosures need to be demarcated for the visitors and relevant large sized signages need to be developed.
- 5. A nature trail route, with relevant signages inside the Zoo also needs to be developed for the visitors.

Note: Bidders are advised to study all technical and commercial aspects, instructions, forms, terms and conditions carefully in the tender document. Failure to furnish all information required in the Tender or submission of a bid not substantially responsive to the tender document in every respect will be at the Bidder's risk and may result in the rejection of the bid and forfeit of the EMD

(3) Eligibility for Interested agency/organizations:

- 1. The interested party may be a registered Company/Firms/ Agency/ having not less than 5 years' experience in designing, supply and installation of the signages and Map of the Zoo or similar works on issues for reputed institutions/organization.
- Designed and implemented at least 30 projects in wildlife interpretations.
- 3. In the last three years have neither failed to perform any contract nor have any Contract terminated by any public entity for breach of contract.
- 4. The prospective bidder shall have a cumulative miniumu average annual turnover of minimum Rs. 10.00 (ten) crore in similar tasks for each of the last three financial years i.e. 2016-17, 2017-18 and 2018-19.
- 5. Have work experience of 5 years for development of interpretation/information Centre.
- The tender is "Three Bid' document i.e. (i) Technical Bid, (ii) Presentation & Demo and (iii) Financial Bid. The tenderer will submit the technical bid with all the relevant information and desired enclosures in the enclosed prescribed format (Annexure-1) along with scanned copy of the Earnest Money Deposit (EMD). The financial bid should contain only commercial document and should be submitted in the enclosed format (Annexure-2). In case, any bidder encloses the financial bid within technical bid, the same shall be rejected summarily.

#### Technical Bid: **(I)**

The Technical proposal shall contain:

- 1. Earnest Money of Rs. 50,000/- only in the form of Bank draft/Demand draft of any nationalized bank payable at Patna local branch in favour of the Director, Sanjay Gandhi Biological Park, Patna.

5. Experience Certificates of last five years in the similar nature of work (minimum 30

projects in wildlife interpretations)

6. CA certified copies of audited balance sheets of Annual turnover of minimum Rs. 10.00 (ten) crore in similar tasks for each of the last three financial year (2016-17, 2017-18, 2018-19)

7. Notarized document stating that they never blacklisted by any govt. agency and no govt. enquiry against company is going on.

8. Affidavit that neither failed to perform any contract, nor have any contract terminated

by any public entity for breach of contract.

9. Any other necessary document related to this tender.

### (II) Presentation & demo by the bidder.

After evaluation of the Technical Bid, the selected bidder will have to give presentation and demo of the signages and map of the zoo before the Tender Committee. The bidder is required to show/submit at least one piece of the following signages and Map of the Zoo:-

(i) Animal Enclosure Signages
Hard Anodised Aluminium Plate with Size of 18" X 24" to be fixed with
proper size metal pole structure.

(ii) Multiple Directional Signages- Epoxy Printed on fundermax material each

strip size: 6" X 24"

(iii) Map of the Zoo- Hoarding type with 3M brand vinyl for multicolor design with board size: 4' X 8'

After presentation of demo of Animal Enclosure Signages, Multiple Directional Signages and Map of the Zoo, the Tender Committee will select the best three samples of each of the above signages and map respectively.

## (III) FINANCIAL BID

After selection of best three samples of each of the above signages and map, the Tender Committee will open only the Financial Bid submitted by the selected bidders.

## (6) AWARD OF THE CONTRACT:

Sanjay Gandhi Biological Park, Patna (PATNA ZOO) will award the contract to the successful bidder for implementation. The successful bidder has to sign an agreement for implementation of the project within stipulated period on the non-judicial stamp of Rs. 1000/duly purchased and submitted by the successful tenderer in the office of the Director, Sanjay Gandhi Biological Park, Patna.

#### (7) Refund of Earnest Money Deposit:

The EMD submitted by unsuccessful bidders shall be returned to them without any interest whatsoever, within 30 days after conclusion of the contract with successful bidder. The EMD submitted by successful bidders shall be kept as Security Deposit and will be returned after successful completion of the work. In case the successful bidder fails to comply with the stipulated conditions, i.e. signing of agreement and completion of awarded work in time, the EMD will be forfeited to Government.

#### (8) Payment terms & conditions:

- 1. 60% payment of the total order value will be made on receipt of the material at store.
- 2. 30% payment of the total order value will be made after successful completion of the 90% project work.
- 3. 10% payment of the total order value will be made after receipt of completion report from competent authority.

### (9) Tenderer rights on accepting the bid

The Sanjay Gandhi Biological Park, Patna does not bind himself to accept the lowest bid or any bid and reserves the right of accepting the whole or any part of the bid or portion of the job offered; and the bidder shall provide the same at the rates quoted. The Sanjay Gandhi Biological Park, Patna reserves the right to reject any or all the offers received in response to tender or cancel or withdraw the tender notice without assigning any reason, whatsoever. Sanjay Gandhi Biological Park, Patna reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document including quantity/ amount of items to be supplied or to reject any or all the tenders without giving any notice or assigning any reason. The decision of the Director, Sanjay Gandhi Biological Park, Patna in this regard shall be final.

## (10) GENERAL ELIGIBILITY CRITERIA OF THE BIDDER.

- a) The Invitation for Bid is open to all Individual/ Company/ Firm/ Agencies, having not less than 5 years' experience for designing, supply and installation of the signages and Map of the Zoo ((minimum 30 projects in wildlife interpretations). The bidders shall be eligible to participate only if they fulfill the qualifying/ eligibility criteria specified in tender Notice.
- b) Bidder should be registered with <a href="https://www.eproc.bihar.gov.in">https://www.eproc.bihar.gov.in</a> with own digital signature.
- c) If the bidder gives deliberately wrong information to create conditions for acceptance of the tender, Sanjay Gandhi Biological Park, Patna reserves the right to reject such tenders without assigning any reason. Not more than one tender will be submitted by one bidder for the same work. Legal action will be taken for furnishing wrong information.
